The Creditors have to submit their claims to the Resolution Professional as prescribed under Regulation 7 of the Insolvency and Bankruptcy Board of India (Insolvency Resolution Process for Personal Guarantors to the Corporate Debtors) Regulations, 2019, in Form-B. The Last Date for submission of Claims of creditors is -31.08.2026 (21 days from the date of issue of notice). The creditors may submit their claims by way of electronic communication, or through speed post or registered post.
