Sub: Intimation of commencement of Bankruptcy Process in respect of Mr. Chand Kumar Goyal (PAN No: ACDPG5590L) (Personal Guarantor of M/S Giriraj Timber Private Limited).

Dear Sir,

I hereby intimate you that Bankruptcy Process has commenced in respect of Mr. Chand Kumar Goyal (PAN No: ACDPG5590L) (Personal Guarantor of M/S Giriraj Timber Private Limited, under the provisions of Insolvency and Bankruptcy Code, 2016 ("Code") by an order dated **22.05.2026 of Hon'ble NCLT Delhi Court-II, IA-968/ND/2025 in (IB) – 414/(ND)/2022**. Copy of the order dated 22.05.2026 is annexed herewith.

The Adjudicating Authority gave some instructions for publishing of the Public Notice in Para 17 and 18 of its order dated 22.05.2026.

17. The Bankruptcy Trustee shall issue public notice under section 130(1) (a) of the IBC within ten days from the date of this order to the creditors mentioned in the statement of affairs, if submitted, and to the creditors mentioned in the present Application.

18. The Public Notice inviting claims from the creditors under section 130(2) of the IBC shall be published in two leading newspapers, one in English and one in a vernacular newspaper, having wide circulation at the place where the Bankrupt resides.

It is pertinent to note that the Resolution Professional after receiving the order, made a Public Notice on 28.05.2026 in Jansatta- Delhi Edition (Hindi) and Financial Express Delhi Edition (English) inviting claims from the creditors of **Mr. Chand Kumar Goyal**. A copy of Public Notice is annexed herewith.

Furthur, as per section 130(2) of the IBC , as reproduced below:-

The public notice under clause (b) of sub-section (1) shall include the last date up to which the claims shall be submitted and such others matters and details as may be prescribed and shall be -

(a) published in leading newspapers, one in English and another in vernacular having sufficient circulation where the bankrupt resides;

(b) affixed on the premises of the Adjudicating Authority; and

(c) placed on the website of the Adjudicating Authority.

Hence, in compliance of the same, you are kindly requested to place Public Notice on the website of the Adjudicating Authority.
