NOTICE

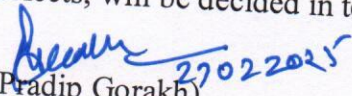
A notice was issue under rule 28(2) on 14/02/2025, wherein all the concerned parties were directed to remove defects from list of matters annexed therein, within 21/02/2025. However, it is observed that many of the concerned parties have still not rectified the defects.
