
NOTICE

Attention in invited to Rule 28 (2) of NCLT Rules, 2016, wherein it has been provided that on scrutiny, if an Application is found to be defective, after notice to the party, the same shall be returned for compliance. If the defects are not complied within 7 days, the Registrar may pass appropriate orders.

On scrutiny of the Petitions/ Applications received by the this Tribunal under various sections of IBC, 2016 and Companies Act, 2013, it is found that certain defects were raised by the Registry and the list of 'Common Objections' were also published in the website of NCLT date 17.3.2022, 25.3.2022 and 4.4.2022.

In spite of list of 'Common objections' published on 17.3.2022, 25.3.2022 and 4.4.2022 for rectification of defects, the same has not been complied with so far. Hence, in view of Rule 28 (2) of NCLT Rules, 2016 notice is hereby given to the parties, as a last chance, to rectify the defects within a period of **7 working days** from the date of this notice, failing which all these Petitions/Applications will be placed before the Registrar for passing appropriate orders in terms of Rule 28 (3) of NCLT Rules, 2016.
