b) Persons, whose names are recorded in the Register of Members in the Register of Beneficial Owners (RBO) of the Company, Depository or the cut-off date is **Monday, 03rd November, 2025** only shall be entitled to vote remotely at the EGM and the e-voting facility of e-voting.
