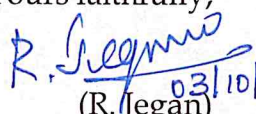

Parents among four arrested for threat to kill newlyweds

A newlywed, 25-year-old software developer has approached the Chettipalayam police seeking protection to his spouse and herself from her parents who allegedly threatened to kill them for marrying a person from the Scheduled Caste.

The police have arrested her parents Murugesan (52) and Chellamai (50) of Karumapalayam in Pollachi, brother Manivasagam (22) and uncle Muruganathan (47). They have been remanded in judicial custody.

Police sources said Pavipriya of the Vettuvu Counder Community had married Sethupathi of Karundampalayam after a love affair for four years.

Initially, Pavipriya approached her parents to get their nod for marriage. However, they had refused nod, citing Sethupathi is from an SC community. Simultaneously her parents had also started searching for another bridegroom.

However, Pavipriya married Sethupathi in August as per the rites of Sethupathi's community. She visited her house last month to tell her parents about the wedding but they threatened to kill them.

Subsequently, Pavipriya lodged a complaint at the Chettipalayam police station, fearing 'honour killing' and all the four were arrested on Friday.

Police registered a case against them under BNS sections 191(2) (violating), 127(2) (wrongful confinement), 115(2) (voluntarily causing hurt), 351(3) (criminal intimidation) and the Tamil Nadu Prohibition of Harassment of Women Act.

Vet injured by wild elephant 'Rolex'

Veterinary Assistant Surgeon of Anamalai Tiger Reserve (ATRT) K Vijayaragavan was injured in a wild elephant attack at a grove in Perumangalam Palayam near Thondamuthur early on Saturday. He is undergoing treatment at a private hospital in the city.

The incident occurred when a team consisting of veterinarian Vijayaragavan, along with forest range officers V Thirumurugan (Coimbatore), K Jayachandran (Boluvaipatti), wild elephant trackers, Anti Poaching Watchers (APWs), Kunkki mahouts and kavadis were monitoring the behaviour of the tusker, 'Rolex', in a bid to capture him.

The veterinarian, along with the members in the team, was walking behind the animal at the banana plantation grove at 1.15 am on Saturday when the animal suddenly turned and pushed him down.

The others managed to escape from the spot. After noticing the incident, a few members in the vehicle honked and shouted to prevent the animal from charging at the veterinarian.

Subsequently, the tusker left the place and Vijayaragavan was rescued. Sources in the forest department said that there were no major injuries to the veterinarian.

A senior official of the forest department said Vijayaragavan got minor injuries on his finger and back, and he was taken to a private hospital in a Met-Bupalam Road, where he underwent a full CT and MRI scan.

"He has a small burst fracture in the twelfth thoracic vertebra (T12) and left ring finger distal phalanx has an open fracture, and he also underwent minor surgery in his spine," said the official.

PG admissions hit as BU's Erode centre shuts portal

THE Association of University Teachers (AUT), Zone IV, has alleged that Bharathiar University is denying admission for postgraduate courses at its Postgraduate Extension and Research Centre in Perundurai, Erode, even as the deadline has been extended.

AUT Zone IV Chairman A Balasankar told TNXZ the Higher Education Department has extended the admission deadline for PG courses in government colleges and universities for the current academic year until September 30.

"At present, the admission portal for receiving applications from students is active in all colleges and universities, except at the Postgraduate Extension and Research Centre in Perundurai. Referring to the Higher Education Department's directive,

we requested Bharathiar University to open the portal for admissions at the Perundurai centre. Even after 30 days, the university administration has been refusing to open the portal without providing any reason," he alleged.

"At present, the centre is offering five courses this academic year and fewer than 50 students have enrolled. Another 15 more students are ready to join if the university opens the admission portal," he said.

He further said that the admission process at the centre began late in June, and as a result, some students joined private colleges. He urged Bharathiar University to commence admissions earlier at least from the next academic year.

When asked about the issue, Bharathiar University Registrar R Rajavel told TNXZ that he would look into the matter and take the necessary steps.

Railways adds coaches to UDAY express

Coimbatore: The railways has augmented the Bengaluru-Coimbatore-Bengaluru UDAY double-decker express train with two additional AC chair car coaches, effective September 22. The KSR Bengaluru-Coimbatore UDAY Express (22655) will be permanently augmented with two chair car (second-class, reserved) coaches starting on September 22, and in the reverse direction on September 23. Coimbatore man gets life for murdering wife

Coimbatore: A Coimbatore District Court judge on Friday sentenced a 55-year-old man in life in prison for the murder of his wife three years ago. Additional District Judge PK Sivakumar sentenced K Ramanathan of Priya Nagar in Telugupalayam Privil in Selvapuram to life imprisonment for the murder of his wife Anuradha (50), under Section 302 of IPC. He was also ordered to pay a fine of ₹5,000. According to sources, in January 2020, Ramanathan stabbed his wife to death after she scolded him for not going to work. Based on a complaint from Anuradha's father Arumugam, Selvapuram police registered a case against him.

Advanced English training for govt teachers

Coimbatore: The Directorate of Elementary Education (DEE) is planning to conduct an advanced English language training programme for government primary and middle school English teachers. After the training, the DEE has asked district Chief Educational Officers (DEOs) to submit a list of interested teachers. The list should include additional details such as the teacher's school's name and mobile number. "To improve English teaching skills, the experts will provide training on advanced English and teaching methods to teachers who teach English in classes 1 to 8 at the district level," said a DEO in Coimbatore.
