Dear Sir/Ma'am,

This in reference to the matter of State Bank of India Vs. Mr. Amrit Pal Singh Chadha, in in I.A. No. 1122/ND/2024 in C.P. No.: (IB)- 458/(PB)/2021, wherein the Hon'ble NCLT, New Delhi, Principal Bench has passed order dated 1st May, 2024 (Order uploaded at NCLT website on 10th May, 2024) under Section 100 of IBC, 2016 for initiation of Personal Insolvency Resolution Process against you. Further, the undersigned has been appointed as Resolution Professional to discharge his duties under the applicable provisions of IBC, 2016 and the Regulations made thereunder. A copy of the aforesaid NCLT order dated 1st May, 2024 has been annexed herewith.

In accordance with Section 102 (1) of the Code, a public notice has to be issued within seven days of passing of the order u/s 100 of the Code, inviting claims from all creditors within 21 days of such issue. The notice shall include details of the present order, particulars of the Resolution Professional with whom the claims have to be registered, and the last date for the submission of the claims. The said notice shall be –

- a) published in English and one Vernacular Language newspaper which is in circulation in the State where the debtor resides;
- b) affixed in the premises of this Adjudicating Authority; and
- c) placed on the website of the Adjudicating Authority.

A public notice dated 14th May, 2024 has been issued, under Section 102 of IBC, 2016 in newspapers Financial Express (English) and Jansatta (Hindi) having wide circulation in Delhi
