Dear Sir/Ma'am,

This in reference to the matter of State Bank of India Vs. Mr. Sumit Juneja, in I.A. No. 5504/2024 in C.P. No.: (IB)- 572/(ND)/2024, wherein the Hon'ble NCLT, New Delhi, Bench-V has passed order dated 13th August, 2026 (Order uploaded at NCLT website on 15th August, 2026) under Section 100 of IBC, 2016 for initiation of Personal Insolvency Resolution Process against Mr. Sumit Juneja. Further, the undersigned has been appointed as Resolution Professional to discharge his duties under the applicable provisions of IBC, 2016 and the Regulations made thereunder.

A copy of the aforesaid NCLT order dated 13th August, 2026 has been annexed herewith.

In accordance with Section 102 (1) of the Code, a public notice has to be issued within seven days of passing of the order u/s 100 of the Code, inviting claims from all creditors within 21 days of such issue. The notice shall include details of the present order, particulars of the Resolution Professional with whom the claims have to be registered, and the last date for the submission of the claims. The said notice shall be –

- a) published in English and one Vernacular Language newspaper which is in circulation in the State where the debtor resides;
- b) affixed in the premises of this Adjudicating Authority; and
- c) placed on the website of the Adjudicating Authority.

A public notice dated 19th August, 2026 has been issued, under Section 102 of IBC, 2016 in newspapers Business Standard (English and Hindi) in Jaipur Edition and also in Financial Express (English) and Jansatta (Hindi) in Delhi Edition having wide circulation in the state where the debtor resides for inviting claims from all creditors within the last date of submission of claims i.e. 9th

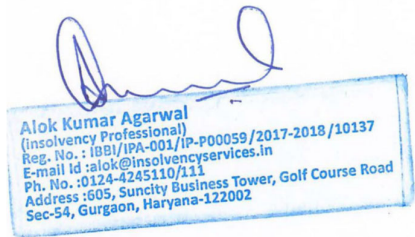
