





**ORDER**

1. It has been observed that the Advocates/Representatives of Statutory bodies, State and Central Government Departments etc., are attending the proceedings before National Company Law Tribunal without filing Vakalatnama / Memo of Appearance. Sometimes they appear through Proxy. New Advocates/representatives also appear without deleting the name of the earlier counsel / representative. This is causing confusion in the proceedings.
2. All Advocates/Representatives of the office of Regional Director, Registrar of Companies, Official Liquidator, Income Tax Department, Competition Commission of India and Reserve Bank of India etc are directed to file Vakalatnama / Memo of Appearance in each case wherein they are appearing before all benches of National Company Law Tribunal, if, not already filed.
3. The Departments as above are requested to instruct their Advocates/ representatives to file Memo of Appearance/Vakalatnama wherever applicable and represent the matter.
4. It is informed that in the absence of Vakalatnama / Memo of Appearance their attendance will not be marked in the proceedings.
